The Alaska Chamber supports the Bureau of Land Management moving forward in the process to prepare the Coastal Plain Oil and Gas Leasing Program.

The Chamber is a non-profit founded in 1953 working to promote a positive business environment in Alaska. The Chamber is the voice of small and large business representing hundreds of employers and local chambers across Alaska. Our member companies employ over 100,000 hard-working Alaskans. We have long supported resource development that is both done in a responsible manner and brings economic opportunities to Alaska and its residents.

A long-standing top federal legislative priority for Chamber members is supporting oil and gas exploration within Alaska's federal areas, and the eventual production from those exploration activities. The responsible development of the oil and gas resources found in the 1002 area of the Arctic National Wildlife Refuge (ANWR) represents thousands of high-paying jobs for Alaskans and a considerable injection of revenue into Alaska's economy.


The Alaska Chamber supports BLM's efforts to move forward in this process and to the eventual positive lease sale in the 1002 area of ANWR.
