*A Message From Our  
President*



This past month, I attended a meeting with Governor Scott along with local business leaders and elected officials. The conversation was in regard to opposing Florida House bill HB7005, which is a bill that would end economic diversification efforts in Florida by eliminating the economic development toolkit, international programs, and marketing and small business assistance. Additionally, this bill cuts tourism marketing by 67 percent. Subsequent to this meeting, the Florida House Appropriations Committee has

voted by an 18-12 margin to advance this bill. Thank you to Representative Jared Moskowitz for opposing this bill and taking a stand to support Economic Development and tourism. However, despite all of the citizens and business opposition to HB7005 the conversation of eliminating Enterprise Florida and two dozen important programs will now move to the Florida House Floor.

The Coral Springs Regional Chamber of Commerce Board of Directors believes that Florida must continue to fund initiatives that support diversifying the economy and attracting visitors and businesses to our state. Looking ahead, your efforts and comments will be needed. So please, "stay tuned" for additional announcements on how you can help. We hope you will continue to join our fight to oppose any efforts to dismantle the state's role in
