#### **POLICY AND ADVOCACY REPORT**

2013-2014 was a stellar year by any measure for the Windsor-Essex Regional Chamber. Here are some highlights of our achievements.

#### **AWARDS**

The Chamber won two prestigious Ontario Chamber awards in 2014 for its advocacy and community leadership. The Ontario Chamber of Commerce recognized the Windsor-Essex Regional Chamber for its role in advocating for Bill C-290 also known as the single sports betting bill "to let the provinces decide". The Windsor Essex chamber nationalized a key local issue by getting local and provincial chamber in Canada to support it. The bill currently sits in the Senate.

#### **CAMPAIGNS**

The Chamber successfully completed or significantly advanced several advocacy campaigns, among them are the following:

Agri-Food is one of the top two industries in Ontario as well a big contributor here in Windsor- Essex, and the Chamber's paper received strong praise from the Canadian Chamber of Commerce and good media coverage for our first Agri-Food research paper. The paper was the foundation advocacy document for three successful Ontario Chamber resolutions laying the foundation for more economic activity and jobs.

Auto Strategy continues to be the most important sectors for the Windsor-Essex region and is a strong contributor to our economic growth and prosperity. Beginning with business, labour and academia coming together at our highly successful non-partisan Policy and Solutions forum in May, the Chamber built its provincial and national campaign for a national automotive strategy.

Workforce development is a critical need for industry as is training and education to develop industry specific skills. The Chamber advanced the skills portfolio by advocating for workforce development in the agri-food sector and by addressing the issue of immigration as a significant source of skills for our business community. Key partners include Workforce Essex Windsor, St. Clair College and OCC.

Canada-U.S. Border continues to be one of the most important policy and advocacy areas for the Windsor-Essex region. The Chamber authored two Canadian Chamber policy resolutions related to the Canada-U.S. Border advancing the issues related to our competitiveness and the increasing costs of crossing the border. The Chamber also advanced the issues related to great lakes marine shipping.

Costs of Power was a key chamber member and the Windsor Essex Chamber led the way in Ontario by being the first chamber to release its policy paper as the foundation advocacy document and is now used by many across Ontario. It was used successfully to help push for lower costs and year round Greenhouse operations.

#### **POLICY COMMITTEE REPORT**

#### **ELECTIONS**

The Chamber continued to fulfill its leadership role in the community influencing the government by its award winning election strategy to shape key issues in every election. The Chamber identified the most important business and community issues by surveying its members and then hosting a debate.

Based on its own award winning strategy the Chamber held two all candidate debates.

- July 2013 Provincial By-Election all candidate debate for Windsor-Tecumseh
- June 2014 Provincial Election all candidate debate for Windsor-Tecumseh, Windsor West and Essex

#### **POLICY COMMITTEES**

The Transportation Committee received national chamber support for its opposition to the Maritime Goods Movement Act. This tax was ultimately scrapped by the US Government.

#### **RESEARCH**

On April 17, 2014, the Chamber released its first Regional Agri-Food Paper (AFP), its fourth comprehensive research paper since February 2013.

The Chamber positioned the agri-food sector is the number one or number two industry in Ontario, depending on how it is measured. In the Windsor-Essex region, it is a \$1 billion industry and it is well positioned to grow.

The Chamber's Finance and Taxation Committee provided research, expertise and coordination for the Chamber's first ever Policy and Solutions Forum.

The Transportation and Environment and Energy Committee contributed to research needed to create a first-rate advocacy platform. The two committees supported numerous position statements and policy resolutions at the Ontario and Canadian Chamber of Commerce Annual General Meetings needed for the Chamber to be a more effective voice of business on the provincial and the national stage.

#### **FORUMS**

The first ever Policy and Solutions Forum was the most significant achievement for the Chamber in 2013-2014 and one of its most valuable contributions to the Windsor-Essex search for economic prosperity.

The non partisan forum was created by the Chamber to advance the debate and to provide a stepping stone for the development of future policies and roadmaps for economic growth and development.

The key message from the forum presentations was the need for collaboration between industry, labour and governments in addressing the economic development of our region.

As a team of driven individuals, our efforts have been focused on generating value for our membership to achieve membership retention.


