Alarming News..... According to the SBA 2016 Survey 44% of small businesses reported being the victim of a cyber attack - average cost \$36,000.
4,000 attacks on Small to Medium-sized Businesses (SMBs) ...a day. When notified you have a problem, someone has been inside your network undetected on average for 205 days - FireEye M-Trends 2015: A View from the Front Lines Furthermore, 60% of small businesses attacked go out of business in 6 months - U.S. Nat'l Cyber Security Alliance. With small to medium sized businesses being the main target.

The threat landscape consists of Hacking, Phishing and Ransomware. Targeted attacks start with an email. Keyven went on to explain how each of these threats works and how to become more aware of potential threats.

MAJOR TRAFFIC SWITCH ON US 287 SET FOR THIS WEEKEND

JUNE 26, 2018

ENNIS, TEXAS - All northbound and southbound traffic on US 287 will begin to be switched over to the new northbound frontage road of US 287 from SH 34 to I-45 on Friday, June 29 starting at 9 a.m. for the next phase of construction. The northbound lanes will be switched on Friday morning after rush hour and the southbound lanes will be switched on Saturday during the day. Please pay attention to the new signs and maintain caution through the construction zone.

The US 287 project spans from south of SH 34 to I-45 south in Ennis and includes widening the two lane roadway to a four lane divided highway with grade separated interchanges. This \$61.7 million project began in May of 2017 and is

estimated to be completed in the summer of 2019.
