

SUMMERTIME IN HUDSON MEANS COMMUNITY CELEBRATIONS AND FESTIVALS

July brings a beehive of activity for Hudson! Community celebrations kick off with a grand entrance during

Independence Day weekend and continue throughout the remaining weeks of summer and into early fall.

While Hudson residents enjoy many of these traditions, community celebrations are not for locals alone. The energy and activity these activities create only enhances the charm and excitement in our community. Dining out is bustling at all types of diners, restaurants, taverns, lounges and bars that are featuring fun fare for the season. Shops and boutiques are offering summer specials. A wide variety of lodging options are available for guests. It all adds up to Hudson being the place to be this summer!

Booster Days kicks off summer fun July

3 - 7. Booster Days is the annual 4th of July celebration held in Lakefront Park in historic downtown Hudson, along the scenic St Croix River. This event draws crowds from Hudson and the surrounding region with activities for all ages. The fireworks show over the St. Croix River takes place Friday, July 5 this year. The weekend also includes a carnival in Lakefront Park, Saturday downtown parade, fishing contest, beer gardens, bingo, kid's activities, car show, contests and live music from multiple bands in the Hudson band shell each night. St. Croix Riverfest, the "Party with a Purpose," runs July 16 - 21. This six-day event celebrates the St. Croix River while recognizing the need to preserve its health and beauty. The celebration commences with the feel-good effort of a river clean up along with a picnic lunch. Family and kid-friendly events on the schedule include story times, art activities, Carpenter Nature


Center presenting Animals of the St. Croix, and Toonies ENVIRO-FUN puppet show. Other activities include yoga and Tai Chi, an evening prairie hike, St. Croix Sailing School open house, Community Band concert in the Lakefront Bandshell, a Riverfest nature boat cruise, Civil War encampment, and a community-wide Potluck Lunch. Looking for a new development opportunity? Leadership Hudson Program now accepting applications.

Leadership Hudson is the Hudson Area Chamber of Commerce & Tourism Bureau's premier community leadership program, bringing together current and emerging leaders from all sectors of the Hudson area. This is a unique opportunity for participants to think about the critical issues facing Hudson while also developing leadership skills.

Leadership Hudson participants will:

- Experience behind the scenes tours to business, arts & culture, health care, education and government agencies.
- Build and enhance your leadership skills through Personal Leadership Development including Strength Finders, Developing and Living Your Brand and Building Upon your Strengths.
- Develop new business connections from a cross-section of the community.
- Hear and interact with high-level Hudson business, community and government leaders.

Time Commitment and Attendance

The program meets the second Tuesday of the month from September 2019 to May 2020. Meeting days are full days, starting at 8 a.m. and typically finish by 4 p.m. Full participation of the scheduled program days is essential to the Leadership Hudson experience. Class members are expected to arrive on time and remain with the class for the entire session.

Employer Support

Because of the time commitment, it is vital that Leadership Hudson participants have the support of their supervisor and employer. Applicants are encouraged to discuss the application process, program cost and time commitment with their employer prior to applying.

Schedule and Cost

We will accept applications through August 1, 2019; applicants will be notified about the status of their application by August 15, 2019. Tuition for the nine-month Leadership Hudson program for 2019-2020 is \$995 (\$1,295 for NON-Chamber members).
