City Commission approves ordinance to help fill vacant commercial buildings on US 1

At the August 27 meeting the City Commission approved Ordinance 44-19 which amended the City's Land Development Regulations. It is anticipated that this ordinance will help fill vacant commercial buildings on US 1.

The ordinance states in part:

"Properties within the U.S. 1 Corridor Special Parking District zoned B-3 shall be exempt from the off-street parking space requirements of this section in cases of a change of use or activation of a terminated use where there is no change to the building footprint."

Previously, a building vacant for six months or longer or a building with a proposed change of use (for example, restaurant to professional office) had to bring their parking area into compliance with the current parking lot standards – which means the parking spaces and drive aisles had to meet city standards, and landscaping areas had to be cut in and plant material installed even if there were no areas provided for landscaping. One such lot next to a vacant building on US 1 was said to potentially lose about 20 parking spaces if landscaping areas had to be installed around the perimeter of the lot.

The ordinance recognizes the special nature of US 1 and no longer imposes those requirements on vacant buildings proposed for occupancy or proposed for a new and different use from the previous use. In the US 1 area there are vacant buildings that require renovation expense, and additional expenditures for parking lot improvements could make a proposed project financially out of reach. The elimination of those

requirements recognizes that situation and it hopefully will make more properties available for renovation.
