The NSVFA Executive Board is pleased to offer a Gold Badge Associate Membership in the Nebraska State Volunteer Firefighters Association. This membership is for any past member of a fire/emergency service department who has either left their respected department due to a job move, illness, or retirement. The current enrollment period is from July 1, 2018, through June 30, 2019.

#### **NSVFA Gold Badge Associate Member Policies:**

- The Gold Badge Associate Member may attend NSVFA Annual Conference meetings, make motions at the meetings and vote at Annual Conference. The Gold Badge Associate Member may address the general membership at Annual Conference upon recognition by the chairperson.
- The Gold Badge Associate Member is provided a \$4,000 accidental death / dismemberment insurance policy. A new grace period for continuation of this insurance has been established by the NSVFA E-Board in that memberships must be paid by September 1 or this benefit will discontinue until such time membership is paid.
- The Gold Badge Associate Member may register to attend the Annual Nebraska State Fire School but does not receive the member discount registration fee.
- As a benefit of their dues, Gold Badge Associate members will receive a one year subscription to the official NSVFA monthly newspaper beginning with the October issue and ending with the September issue. Dues must be paid by September 1 to receive the October issue.
  - Gold Badge Associate Membership dues remain at the annual fee established by the E-Board throughout the current term. Members paying dues late receive the remaining newspaper issues until September 30 of the following year.
  - One month should be allowed for processing addresses for subscriptions to the newspaper to take effect after dues are received.
