Offer Terms & Conditions:

1. Introductory Rate available once to a licensed contractor with an active C20 or C36 license engaged in the plumbing, heating, cooling industry, and who has never been a member of the PHCC Association.
2. Introductory Member may only retain the designation for a maximum of 12 months from date company joined, and must maintain affiliation with National, State and Local Federation as described in Local By-Laws.
3. Introductory Rate includes fifty percent (50%) off National, State and Local dues, and is prorated based on the first month a member joins through year end, or December 31st. Introductory Members:
 - a. Must attend at least 50% of Local Chapter Member Meetings during the Introductory Membership Period;
 - b. Cannot vote, hold office or propose resolutions or amendments to By-Laws unless paying full Annual Rate and becoming a Full Active Member.
4. Local Association Board of Directors reviews membership applications and reserves right to refuse membership based on CSLB status and/or standing in the community.
5. In advance of the PHCC Association approving this application for membership, the undersign affirms:
 - a. I accept and will comply strictly with the laws and regulations stated in the By-Laws of the Association;
 - b. I have read and agree to uphold the PHCC Code of Ethics and do what I can to fulfill the mission statement;
 - c. I agree to attend Association meetings regularly;
 - d. Should my membership be terminated at any time, I will immediately surrender any Association insignias and cease use of Association's decals or seals of membership.
