Regionally Significant Industrial Area Sutherlin's 2012 Designation

"The [Back Nine](#) (130 acres), [Stearns Lane](#) (200 acres), and [Sutherlin Industrial Park](#) (32 acres)—collectively the Central Douglas [Regionally Significant Industrial Area](#)—was approved by the State of Oregon's Economic Recovery Council on September 28, 2012.

This designation means that the industrial zoning for each of these sites is protected, the sites can be given preference in allocation of state economic development infrastructure dollars, and that projects have access to expedited state permitting through the "projects of statewide significance" program.

The Central Douglas RSIA was one of the first two ever designated by the state. It helps to demonstrate that Douglas County is home to some of the best I-5 accessible, shovel-ready, large footprint industrial sites on the West Coast."

"The decision-ready designation is a fast track tool that allows site owners and communities to quickly assess the readiness of their industrial sites and sticks to the primary tenants of certification. While the decision-ready designation does not offer the 180-day employment-ready guarantee, it does reduce risk for potential employers and developers while also helping communities and the state make policy and investment decisions."

With all of those good and positive comments, now two years old, what is happening in the development conversation to improve the region's business climate? Multi-level organizational meetings continue..

Sutherlin Transportation Service Plan Includes an Eight Point Street Plan

"Provide a well planned, comprehensive street system that serves the needs of the Sutherlin area."

Goal #4 states objectives to:

- A. Develop a street classification system to provide an optimal balance between mobility and accessibility for all transportation modes consistent with street function.
- B. Design the street system to safely and efficiently accommodate multiple travel modes within public rights-of-way.
- C. Make better use of the southern interchange by connecting an east-west route to the southern interchange on both sides of Interstate-5.
- D. Identify opportunities to improve flow of people and goods east-west across I-5.
- E. Identify alternative east-west routes to improve traffic flow and improve emergency vehicle access...Identify options for improved access to the Sutherlin Industrial Park.
- F. Balance the needed street function for all travel modes with adjacent land uses through the use of context-sensitive street and streetscape design techniques.
- G. Improve streets in the Sutherlin area to City street design standards.
- H. Identify transportation demand management strategies appropriate to the City of Sutherlin to help reduce vehicle miles traveled and vehicle travel demand."

Where the sidewalk ends...

Recent conversations in city offices regarding sidewalk repairs have awakened a new possibility for plan disruption. Who owns the sidewalks on Central Avenue?

Research is underway to clear up confusion. Some say it is possible there was a revision to the municipal code in 1968 regarding Sutherlin sidewalks and responsibilities for safety and repair. As is the case with most communities property owners are responsible for sidewalk upkeep and repair.

Where the city planted the trees in the sidewalks trees may be part of the reason cracks are appearing and causing damage.

While mapping is reviewed and answers found, sidewalk repair may be on hold. Key in the discussions is the safety to pedestrians. The new City Council will probably be seeing the item on New Year agendas.

The Ford's Pond discussion has been going on for a few years now and evolved into an understanding that Class 'A' effluent will be less expensive than poorer quality Class 'B' or 'C' would be, counter to original estimates. The cost of protecting the public from less acceptable 'B' and 'C' with fences, etc. would, in part, increase the cost above the more favored Class 'A' effluent.

We're gaining a Waste Water Treatment Facility upgrade in the neighborhood of \$22million. The project should be breaking ground by mid 2015.
