Commissioner Morgan aware of employee shortage

Commissioner Morgan mentions in her August 10, 2014 update that Douglas County lacks enough young people to fill our region's jobs over the next eight years, Our population of 15-49 year olds is significantly less than the state average. This is a trend throughout rural Oregon.

Training and experience is another factor. The Oregon age group from 18-25 is 13% of the labor force but accounts for 29% of the unemployed.

All organizations seeking funding assistance are encouraged to contact the Sutherlin Visitor Center and Chamber of Commerce office for instructions on the application process. The funding, if approved, will normally be a reimbursement of expenditures for such items as marketing and publicity.

Grant of \$40,000 for Economic Prosperity Initiative Study

The FCS Group of Portland has been hired to consult with city, county and business leaders to determine effective ways to get the Sutherlin economy on the move to greater prosperity. Meetings began in May, 2014 and will continue on a 24 month timeline. Potential developable properties are under consideration. From a starting list of 18 possible sites the number has been reduced to six sites as most marketable. Assessments include site readiness, infrastructure, wetlands, transportation and suitability for specific industries. Determinations will be made to identify most suitable industries for these properties.

Workforce Availability

A key component of any commercial or industrial enterprise is the availability of a quality workforce. The study will include these assessments. The study will also use SWOT analysis for each of the selected sites. The intent is to accomplish considerable progress toward attracting industry to the Sutherlin area intent on providing long-term job stability.
