MIOSHA Masonry Wall Bracing – Part 2

This course will review the MIOSHA regulations found in Part 2-Masonry Wall Bracing and is designed to teach the training requirements for working in the restricted zones, identification of the proper external bracing, minimum standards for bracing and securing unsupported masonry walls until final stability is achieved, and requirements for a competent person. This course will satisfy the training requirements under Part 2-Masonry Wall Bracing R408.40205(3) for employees working in the restricted zone.

Emphasis will be placed on recognizing hazards and describing safe work practices to eliminate or control those hazards. **Students will receive both MIOSHA and OSHA 10-hour cards upon successful completion of the class.**
