

Spring 2013 is here and we are quickly moving through another year of projects, legislative session, etc. By the time you receive this magazine the legislative session will be nearing its end. We are watching several bills this session that could impact our membership and emergency

services in Texas. T\*Flag Chairman Dan Key will be covering several of these bills in his article on page 8.

SFFMA has several projects we are working on that have kept us busy. I'll provide a summary of several of the projects to let you know what all SFFMA is doing for you. I encourage you to take advantage of some of our benefits, membership benefit providers, and stay informed on things that are going on in our state.

SFFMA's new office building construction is proceeding ahead of schedule. In the month of April we will see the foundation being poured and the framing soon starting. The project has gone well and hasn't run into any major hurdles. We have recently installed a web camera on the Manchaca Fire Department's station (next door) to allow for you to view the progress of the construction. Please go to our home page and click the building progress button on the left hand side of the website to view the latest pictures on the project. If all goes as planned, the builders are expecting a 9-month build time.

Our database is undergoing an upgrade that will allow our membership more information, options, interaction with other members, staff, etc. We have implemented a new server that will allow for a more stable environment, website content management, future growth/memory and faster access to membership/certification records. We are hoping this upgrade project will be done in the coming months after thorough testing.

Several grant programs are still underway including the DHS Training Travel Assistance

Grant that was awarded to SFFMA for assistance in the travel costs associated with getting firefighters trained. A button is located on the front page of our website to access the application for this grant program. The Trusted Choice VFD grant program is a new grant program administered by the Trusted Choice Independent Insurance Agents of Texas. It provides VFD departments up to \$5000 for equipment or fire prevention programs. The initial program has been well received and we have received numerous applications for this program. (Grant application closed on March 15th). The DHS Recruitment/ Retention program that SFFMA was awarded continues with us purchasing air time across Texas in various markets to help local departments recruit new members. We started 2013 with a media campaign run in the Panhandle area composed of billboards, TV airtime, and newspaper ads. We still have recruitment/retention banners, posters, etc available to departments across Texas. We have several new benefits that have been recently rolled out to our membership including retail discount programs, several discount programs on life and other insurance programs. The latest list of benefits can be found in this magazine or on our website under the Join SFFMA tab.

### PRESIDENT'S FORUM

My term as President to date can be described as "fast and furious!" I know that conjures-up negative thoughts these days, but in the context of this forum it describes the activities of your Executive Board and

that of the state office.

As soon as the 2012 Training Conference and Convention came to an end, your Board was off and running. In our first meetings in June and July as your newly elected Board, we identified two areas of focus, the 83rd Legislature Session and the long-term future of the State Firemen's and Fire Marshals' Association of Texas (SFFMA). Over the last several months, we have developed strategies and objectives for moving forward on the premise that what we do in the next five years will affect the SFFMA ten, fifteen, and possibly twenty years from now.

In October last year, the Board held a retreat in Manchaca for our annual budget workshop and to discuss the future of the SFFMA and annual conferences. We enlisted the assistance of TEEX Program Director, Dr. Brandi Plunkett, to facilitate the process and keep us focused.

The process began with a discussion of what we think the purpose of the Training Conference and Convention currently is, and what we believe it should be. Survey feedback of previous conferences was a crucial tool to help us understand what our members value when it comes to conference location, content and time of year. The Board values your input in SFFMA matters and the surveys are an apparatus for us to obtain it. I urge you to take the time to participate in future surveys.

Our debate affirmed the strength of the SFFMA is in the certification program. Without the certification program we lose our niche in the Texas fire service. We acknowledged the laborious work the Certification Board has put into retooling our certification program to make a good system even better. We provided the Certification Board with aggressive objectives in order to better align with the strategic direction we set for the SFFMA. That work continues and an update will be provided during The Woodlands conference. We examined the best ways to market our strategic direction and concluded that it

strategic direction and concluded that it needs to be at the District level and that we needed to engage our Districts. To that end, we scheduled a strategic planning retreat for District

Officers. This event took place on February 23rd in Waco and was well attended with only two Districts not represented. The Board's vision for the SFFMA and future conferences was well-received by the District Officers. They provided the Board with strategic ideas to be implemented at the District and state levels. I encourage you to attend your District meetings to learn more about what your Dis-

trict is doing and how you can be a part of it. The Board took a break from retreat activities on Saturday, October 20th, to hold an official groundbreaking ceremony for the new SFFMA office, which many of you attended. The state office staff and Manchaca VFD did an outstanding job of hosting and coordinating the ceremony and providing a delicious meal. The loan for the building closed on January 22<sup>nd</sup> and heavy equipment started moving dirt on January 28th. At the writing of this article, construction on the building is ahead of schedule and expected to be complete in August. The Board is very excited about what this new building means for the SFFMA and we have you to thank for it!

Planning for the 137th SFFMA Training Conference and Convention at The Woodlands began with a successful planning meeting at The Woodlands Marriott, January 4th and 5th. The Board has changed the conference schedule for 2013 to provide time for the traditional competitive events such as Pumper Races, Kids Event, Driving Contest, and Golf Tournament, while affording more time for attendees to attend training sessions of interest. The Pumper Races and Kid's Activity will be held on Saturday afternoon. The Driving Contest and Golf Tournament schedules remain unchanged in 2013.

The Speaker and Training Committee have done an outstanding job of developing training tracks and sessions that will interest everyone. We have speakers and presenters from all over the country who will conduct fifty-six sessions in thirteen tracks during two days of training.

If there's one disappointment leading to the June Conference, it's the availability of room at the host hotel. The rooms that had been blocked at the state rate filled quickly and the hotel made a business decision not to extend additional rooms at that rate. However, Gabi has done an excellent job of securing overflow hotels nearby at lower rates. Attendees staying at overflow hotels will be able to park in the parking garage behind the Marriott at no charge while attending activities at the host hotel.

I want to invite everyone to attend the President's Reception Sunday evening immediately following the first business session. The event will take place at Town Green Park, just walking distance from the hotel. I promise good food, good music, a great time, and relaxing atmosphere.



governor, was on March 8th. With the start of the Legislative Session, the newly-created Texas Emergency Services Political Action Committee (TES-PAC) started meeting weekly via conference call.

TESPAC was formed to provide a political voice for the thousands of emergency services personnel who serve our state. Our purpose is to raise and distribute funds to support legislators and candidates for public office who understand the importance of promoting and protecting individuals who serve as volunteer firefighters, on EMS squads, and industrial fire brigades. Not to be confused with T\*FLAG whose duty is to study and take necessary action on such legislative matters as may come to their attention; to initiate and promote such legislation as may be necessary to preserve and promote the best interests of the firefighters of Texas. TESPAC is tracking Bills of interest and networking with fire service consortium partners to support or oppose related Bills. You can find more information regarding TESPAC on the website under SFFMA News. The SFFMA hosted the traditional Legislative Day and Firefighter Memorial at the Capitol in Austin on March 20th. The day started early with the Fire Service Consortium Legislature Breakfast sponsored by VFIS of Texas. Legislation information and discussion was provided by the SFFMA, Texas Fire Chiefs, SAFE-D, TCFP, Texas A&M Forest Service, and Texas A&M Engineering Extension Service. Trey Blocker continues to do a great job as our lobbyist and presented the Bills we are supporting this Session. He opened his presentation by recognizing how much Steve Perdue is missed in Austin. This is the first Session in many without Steve walking the Capitol halls and schmoozing the legislators. Trey then introduced Dan Key as the new T\*FLAG Chairman and touted his ability to fill Steve's shoes.

The Legislative event continued with the Firefighter Memorial Service on the south steps of the

Capitol followed by a Pipe and Drum march to the Firefighter Memorial Statue for the unveiling of the inscribed names of the seven volunteer firefighters who died in the line of duty in 2011 and 2012. The Memorial was well attended by LODD families, career and volunteer fire fighters, and Fire Marshals from all over the State of Texas.

Immediately following the Memorial was the renowned catfish fry on the Capitol lawn for our legislators and their staff. As always, this was the highlight of the day for all.

The remainder of the day was spent visiting legislators or their staff members, to provide information and flyers on Bills we ask they support.

So as you can see it has been "fast and furious" for your Executive Board and state office since the Houston conference last

We are doing things we think are in the best interest of your Association, will help us grow, and is for the betterment of the Texas fire service. As always, if you have questions, comments, or ideas, please feel free to contact any of your Board members or the state office.

In closing, I'd be remiss if I didn't recognize all that you are doing to protect the citizens of your community and state. A majority of the state continues to be in drought conditions with no end in sight. As I write this article, many areas of the state are already starting to experience wildfires requiring mutual aid and state supported response. ### CERTIFICATION

### Previous Training not reported correctly through SFFMA Online

As you're probably already aware, some objectives for levels already earned are reporting as not completed. A small portion of these objectives are due to the 2012 realignment. The majority, though, are due to a programming change that is currently being reviewed by the programmers.

When the Certification Board realigned the objectives to NFPA 1001, all Firefighter I objectives previously located in Advanced (now Module 4) moved to Modules 1-3. The Board is aware this change shows minor gaps in training. The individual's next level of certification will not be held for these objectives, but the Board expects that as professionals, the objectives will be covered in a timely basis. Additionally, the individual will want to cover the training, because the information may appear on the Firefighter I or II exam as a requisite objective.

For the objectives misreported as a result of the programming error, we do have the programmers reviewing the issue. In the meantime, a quick fix is for the department to add four classes (one for each level: Intro, Basic, Intermediate, and Advanced), and mark the objectives as complete as they now fall in the program. Please review the supporting pages 2-5 attached to the Firefighter application on the website (http://www.sffma.org/pdfdocs/certification/13\_Modules.pdf). The pages show highlighted in yellow where the pertinent objectives now fall in the Module breakdown.

### Progress Reports (annual training summary)

Reports were due on the January 31st and we have had an amazing submission rate. So far 518 reports have been filed for the 2012 training year. Of these, 30 (6%) departments submitted handwritten reports, and 4 (less than .1%) submitted reports generated through FireHouse. The vast majority (93%) submitted their reports using the SFFMA Online program.

The Certification Office staff would like to thank these departments for taking the time to use SFFMA Online, as review of the reports becomes significantly faster and easier.

As stated previously, the Austin Office staff can accept faxed or scanned signatures, which also speeds up the processing of applications and Progress Report cover pages.

Please note that it is a requirement for all departments to show all previous training on progress reports, regardless of reporting method. We do accept and review reports received after the January 31st due date, but must charge the department a flat \$25 late fee.

### **LEGISLATIVE NEWS**



The 83rd Legislature is in full swing as of this writing. Several bills are moving through the process that could have an effect on the Fire Service in Texas. We (T-FLAG, Trey Blocker, Chris Barron and others) are watching these bills and others that

might be brought up. The budget debate is also underway which will determine the level of funding for 2604 grants. Sunset Committee recommendations will affect the Fire Fighters' Pension Commission and other agencies. The Texas Commission on Fire Protection (TCFP) appears to still be moving under the Department of Insurance.

I want to apologize to any of you who feel that T-FLAG has not been kept informed during this legislative session. The process has only been getting up to speed for about 2 weeks or so (early March). Prior to that a lot of procedural actions were taking place such as committee assignments and bill writing before the deadline for submitting bills on March 8.

We had a good turnout for Legislative Day at the Capitol on March 20. The day started out with a well attended breakfast sponsored by VFIS of Texas. Good discussions about budgets and bills were served up along with breakfast. Representatives from SFFMA, TFS, TFCA and the TCFP were there.

We moved from the breakfast to the Capitol to visit with House and Senate members and their staff to ask for their support on key bills that relate to the Fire Service. The Fallen Firefighter Memorial service was held and as usual it was a very moving service during which 7 more names were added to the FF Memorial. Lunch for legislators and staff was served on the Capitol grounds after which more visits were made in the Capitol to finish up the day. I want to personally thank all of you who went to Austin for this important event

We are currently tracking about 10 bills as they make their way through the process of hearings, amendments, language changes and finally to calendars to be brought to the floor of the House and Senate for debate, amendments, a vote and in some cases on to the Governor's desk. We have a ways to go (regular session ends May 27th) so please don't feel left out. If we identify a bill that needs us to make calls or go to Austin for a show of support I know I can count on you to respond.

At this time (late March) the bill we are watching closely is **SB 766**, Volunteer Firefighter Protection Bill; Senator Hegar. This bill will protect Volunteer FF's from being forced to be certified/licensed by any state

agency. This bill includes a definition of what a volunteer Firefighter is. It also will include language to allow VFDs, ESDs, Industrial Brigades and Fire Chiefs to set certification requirements for their individual organizations without state agency oversight.

Other bills on our radar are listed below by number and sponsor followed by a short description. You can go to Texas legislature online to look up more information about these and other bills and where they are in the legislative process.

**SB 1267/HB2751** (Sen. Nichols/Reps. Bell & Clardy) relating to liability of those providing assistance to TFS in the performance of certain fire suppression duties.

**SB 1405/HB 487** (Sen. Nichols/Reps. Bell, Clardy, Flynn, Guerra and Otto) relating to liability of certain persons assisting with manmade or natural disasters.

**SB 1506/HB 3221** (Sen. Schwertner Rep. Springer) relating to fire safety inspections.

**HB 2516** (Rep. Springer) relating to fines for violation of a county regulation prohibiting or restricting outdoor burning.



### CAPITOL MONUMENT'S EXPANSION PROJECT

SFFMA Needs YOUR Help!

Constructed in 1896, the Volunteer Firemen's Memorial on the Capitol's south approach was the second monument added to the Capitol grounds. Each legislative session, fallen volunteer firefighter names are added to the monument for those who gave the ultimate sacrifice. 117 years later, the monument does not have any room left for names to be added. SFFMA was responsible for erecting the monument in 1896 and has been responsible for approving names and paying for the engraving on the monument ever since. Unfortunately the time has come in which we must think about expanding the memorial so that more names can be added to the monument.

In cooperation with the State of Texas Preservation Board (who has ultimate approval of anything going on the Capitol grounds), a memorial expansion project is being proposed which will include large pieces of granite and plenty of room for names to be added to the monument for many, many decades.



This project will have to be paid by SFFMA and initial estimates indicate it will cost over \$100,000 for all of the granite, installation, and site work. If the State Preservation's Board Board of Directors approves this project, we could get started as soon as we have the funding and have it complete by the 2015 Legislative Session.

### HISTORY

During the construction of the present Capitol, on March 28, 1883, Governor John Ireland approved an act passed by legislature "to permit the State Firemen's Association to erect a monument on the Capitol grounds." The law required the monument to cost at least \$5,000 and "that the names of only those firemen who have lost their lives in discharge of their duty as firemen shall have their names engraved on said monument.'

The Firemen's Association did not erect the monument at the time, probably because of the construction of the Capitol, and in February 1895 the legislature amended the 1883 act to provide for the selection of a site for the monument. Jaeggli & Martin of Brenham contracted to build the monument and Frank Teich of San Antonio became the subcontractor for the project. By May 1896, work had begun to erect the monument on the Capitol grounds. By late June, the monument was nearly completed, and the Firemen's Association was planning a dedication ceremony. After completion of the monument on June 30, it was "veiled" in sheeting and unveiled on the afternoon of July 7, 1896 during a statewide meeting of the Firemen's Association in Austin.

In place of the bronze statue of a fireman holding a baby on the monument today, the Firemen's Monument originally had a tall obelisk topped by a granite statue of a firemen holding a large fire hose. The obelisk and original granite statue were replaced by the bronze statue, and the monument, rededicated in Mav 1905 at another statewide meeting of the Firemen's Association in Austin. On the base of the sculpture is stamped "MFD by W.H. Mullins, Salem, Ohio, J. Segesman, Sculptor.

According to newspaper articles from the Austin Daily Statesman, dated July 7, 1896..."the firemen will with much pomp and glory unveil the monument in the Capitol grounds which has been constructed under the personal supervision of the foremen's committee. These ceremonies will be most imposing in every particular, and a chorus of 600 voices accompanied by a brass band and under the leadership of Professor Besserer will render some appropriate music. 106 fire companies were represented.'

8) Letters of Recommendation (no more than 4 please)

9) Pictures may be submitted (No more than 4 please)

All nominations must be submitted to local Districts by a fire department on or before the District's Spring meeting. Submissions must be received with a letter from the fire department and signed by Fire Chief, Assistant Chief or President.

One nominee from each District should be submitted in a sealed envelope to the state SFFMA office no later than the  $4^{\rm th}$  Monday in May. Submissions must be received with a letter from the District and signed by the District President or Secretary.

The state SFFMA office will log in the submissions as received and leave the submissions unopened. The FFOY committee will meet during the last week of May to open the submissions and to select the three finalists based on the above criteria. The nominees will be notified of the results.

The three finalists will be interviewed by the FFOY committee on Saturday morning at the state convention. All nominees will be recognized and the winner will be announced on Sunday at the 1st Business Meeting. All submissions will be returned to the Districts after the state convention.

### Fire Sprinklers in New Homes / State of Texas CO-OP Purchasing

# Fire Sprinklers in New Homes: Why should firefighters care?

Fire in the home poses one of the biggest threats to the people in your community. Nearly 2,500 people per year, on average, die in U.S. home fires. Last year, 83% of people who died in fires, did so in one- and two-family homes. Sixty-seven percent of all residential structural fireground firefighter deaths occurred in one- and two-family dwellings.

Sprinkler advocates across the country, including the fire service, asked for a coordinated effort to encourage the use of home fire sprinklers. NFPA launched that effort through the Fire Sprinkler Initiative®: Bringing Safety Home in 2000.

Starting in 2006, NPFA 1 Fire Code, NFPA 101 Life Safety Code, and NFPA 5000 Building Construction and Safety Code require fire sprinkler protection in all new one- and two-family dwellings. Since 2009, all model safety codes require fire sprinklers in these dwellings. Model codes represent minimum standards of safety to protect the people and the responding fire force in the event of fire in the home. Amending these codes by removing the requirement results in substandard home construction.

Opponents have launched an aggressive campaign to keep the requirement out of the code. Their misleading arguments have been refuted by scientific research; but they have sometimes prevailed due to their political power and influence. To overcome this powerful opposition it is imperative that firefighters understand the importance of the requirement, embrace it, and assist in engaging and providing factual information to stakeholders.

Home fire sprinkler systems are vastly different from commercial systems. NFPA 13D, Standard for the Installation of Sprinkler Systems in One- and Two-Family Dwellings and Manufactured Homes covers "the design, installation and maintenance of automatic sprinkler systems for protection against fire hazards' in these structures. They are cost effective and efficient life safety systems designed to prevent flashover and improve the chance for occupants to escape or be evacuated. Of special interest to the fire service is the added protection that fire sprinklers provide to firefighter safety. They protect structural stability, allowing fire crews to conduct search and rescue operations and perform an offensive fire attack in a more tenable atmosphere.

NFPA 13D requires only the standard operating water pressure of the domestic plumbing system. Most domestic water supply systems are able to manage the operating pressure demands of a home fire sprinkler system. Communities integrating residential fire sprinklers with water supply systems employ practical solutions that satisfy the needs of all stakeholders.

Opponents of the home fire sprinkler requirement claim that smoke alarms provide enough protection in the home. Fire deaths decreased consistently after the requirement of interconnected, wired smoke alarms in new construction. A plateau was reached in the early 90's and the maximum benefits of smoke alarms alone have been achieved.

Sprinkler systems provide additional benefits, on top of the benefits already provided by smoke alarms. Smoke alarms and sprinkler systems work together to provide protection in the home the same way that seat belts and air bags provide protection in the event of a motor vehicle crash. Opponents of residential fire sprinkler systems also like to boast that newer homes are safer homes and that the fire and death problem is limited to older homes. Statistically, the only fire safety issue that is relevant to the age of the home is outdated electrical wiring. Beyond that, age of the home has little to nothing to do with fire safety. A fire at two-o'clock in the morning is equally deadly in a newer or older home.

In fact, new methods of construction negatively impact occupant and firefighter life safety under fire conditions. In 2008, Underwriters Laboratories® (UL) conducted a study to identify the danger to firefighters created by engineered lumber. Its findings also point to the failure of lightweight engineered wood systems used in floors and roofs when exposed to fire. These structures are prone to catastrophic collapse as early as six minutes from the onset of fire. Lightweight floor assemblies and roof trusses are not the only danger to firefighters found in new homes. Passive protection of these assemblies will not solve the problem. The synthetic construction of today's home furnishings also add to the increased risk by providing a greater fuel load.

Larger homes, open spaces, void spaces, and changing building materials contribute to faster fire propagation, shorter time to

flashover, rapid changes in fire dynamics, shorter escape time and shorter time to collapse. Fire sprinklers can offset these increased dangers and create a safer fire environment for occupants and responding fire crews. An NFPA study conducted in 2009 found that the cost of installing home fire sprinklers averages \$1.61 per square sprinklered foot (SF) for new construction. To put the cost of a sprinkler system into perspective, many people pay similar amounts for carpet upgrades, granite countertops, paving a stone driveway, or a whirlpool bath. The Fire Protection Research Foundation released the Incentives for the Use of Residential Fire Sprinkler Systems in U.S. Communities report revealing that typical incentives offered by communities may offset up to one-third of the cost of home fire sprinkler systems. In addition to the life safety benefits provided by home fire sprinklers they reduce the average property loss by 69% per home fire. Home fire sprinklers also protect the environment, reducing carbon emissions by up to 98%. Water conservation is another benefit of home fire sprinklers. Sprinklers flowing for ten minutes require up to 90% less water than water used by firefighter extinguishing methods. Water infrastructure demand is reduced at least 47% when the homes within a community are protected by fire sprinkler systems.

Home fire sprinkler requirements are not intended to replace the fire service. Adopting these requirements has allowed the fire service to keep up with growth, and to continue to provide an appropriate level of service, which many times translate into savings for a community. Most importantly, it reduces community risk and protects new housing stock for generations to come.

Because our contracts have already been awarded through a competitive bidding process, purchasing from our contracts satisfies any State bidding requirements your department is required to meet. Through the Co-Op program, your department can receive the same State of Texas pricing for the more than 1 million commodities available on hundreds of contracts. - Vehicles
- · Heavy Equipment
- Office Supplies
- Fire Protection Equipment and Supplies
- A fuel card that pays a rebate for fuel purchased
- Computers
- Cell Phones and Service Contracts

Note that due to legislation, volunteer fire departments are not currently eligible to make use of our travel

# BRYAN FIRE DEPARTMENT PRODUCES FIRST EMERGENCY PREPAREDNESS PLAN OF ITS KIND IN TEXAS

M any Texans will never forget the wildfires that blazed across the Lone Star State in 2011, challenging the state's 1,900 local fire departments that serve as the first line of defense.

Three thousand homes were destroyed that year. Four million acres of land burned. Often there simply weren't enough resources to effectively contain the forces of nature that ravaged wildlands and urban communities.

The situation could have been overwhelming for the Bryan Fire Department, which serves a community of about 76,000 residents.

But instead it was a call to action.

Bryan Fire Chief Randy McGregor assembled a team in 2012 to work alongside Texas A&M Forest Service in developing a Community Wildfire Protection Plan.

"It's our responsibility to protect our community," McGregor said. "This wasn't something we wanted to do; it was something we needed to do."

A Community Wildfire Protection Plan, or CWPP, identifies wildfire hazards and risks throughout a community and outlines specific strategies for reducing those risks. For example, some neighborhoods in the City of Bryan are in close proximity to large pockets of wildlands, where vegetation can dry out, creating challenges when a wildfire ignites.

Combustible attachments also were identified in some areas, as well as things like minimal access routes and poor signage.

Once the hazards and risks were identified, the group set out to develop mitigation strategies, such as fuels reduction projects, public education campaigns and an ingress/egress plan for high-risk neighborhoods.

"The Bryan Fire Department has some of the sharpest, most

innovative guys I've ever worked with," said Jared Karns, a wildland urban interface specialist with Texas A&M Forest Service. "They've put a considerable amount of time into working on this plan and tailoring it to suit the needs of this community." They also got creative along the way and decided they wanted to do more than a CWPP.



The team's drive and determination resulted in the first Pre-Attack Plan in Texas. The plan – a spiral pocket guide – includes information

firefighters can use to size up a wildfire in the city. It could be particularly beneficial to mutual aid responders who may not be familiar with the area. The plan outlines tactics for fighting wildfire in each of Bryan's five response zones, detailing fuel types, water sources, staging areas, evacuation considerations and contingency plans for each region.

"It's incredibly valuable information for responding firefighters, and it didn't exist collectively on paper anywhere," Karns said. "This could potentially help responders identify their plan of attack before they even get to the fire. At the end of the day, it ensures a safer, more efficient wildfire response."

If mutual aid is called to a wildfire in Bryan, firefighters can pick up a Pre-Attack Plan when they check into the incident. If, for example, the fire was burning around Newton Street in Response Zone One, emergency responders could flip to that section of the plan.

They could then determine that the area is surrounded by a 450-acre area of wildlands. The heavy fuel loading includes grass, juniper and oak, and most of the homes in the area are built with ignition-resistant materials but have combustible attachments.

The Pre-Attack Plan also outlines values at risk in the area, hydrants and other water sources, watch-out situations and evacuation trigger points.

"This is the type of information that sometimes takes several hours to determine when you're thrown into an incident, and unfortunately sometimes homes are destroyed because responders don't have all the tools they need to properly suppress the fire," Karns said. "It's very forward-thinking for the City of Bryan to prepare for the next big wildfire long before it happens."

A TRAGIC TURN OF EVENTS
Two months after Bryan began
gathering data for its CWPP
and Pre-Attack Plan, news of a
late-night fire at the Knights of
Columbus Hall rocked the city.
Text messages, Facebook posts
and tearful phone calls shared the
unthinkable during the earlymorning hours of Saturday, Feb.
16: A firefighter lost his life.

Later that day, another firefighter's life was claimed. Two others remain in a Galveston burn unit recovering from injuries sustained on the night of the fire.

One of the first responders that fateful February evening was Lt. Eric Wallace, a member of Bryan's Community Wildfire Protection Plan working group. Lt. Wallace led Texas A&M Forest Service officials in conducting risk assessments for the Fire Station One response zone.

Wallace was known around the fire department for his initiative. He volunteered to be the BFD's HazMat response coordinator, served on the apparatus committee, helped teach Citizen Fire Academy courses and worked with youth every summer at Fire Gator Camp.

Wallace believed in what the CWPP set out to accomplish and took an aggressive approach to learning wildland firefighting terminology and tactics.

At the 36-year-old's funeral, less than two weeks after he spearheaded the risk assessments for his Station One response zone, Chief McGregor acknowledged the need to finish the projects Eric Wallace started.

"There's an inscription in the front of the CWPP that dedicates the plan to our fallen firefighters," McGregor said. "But what that means to us is that we have to roll up our sleeves and ensure that we carry it out and we make the City of Bryan a safer community."



In its darkest hour, the Bryan Fire Department emerged from the ashes with a plan

in place, a plan that will guide firefighters and potentially serve as a model for other departments to emulate.

# RURAL TEXAS FIRE DEPARTMENTS LOOK TO ENHANCE THEIR WILDFIRE RESPONSE CAPABILITIES

TetraKO Wildfire Protection System and newly announced Texas Community Enhancement Funds.

The large-scale damage caused by wildfires in the state of Texas and across the country have become more frequent – the state will never forget the nearly four million acres burned in 2011. And from January 1, 2013 to February 28, 2013, Texas Forest Service and local firefighters responded to 923 wildfires. As the 2013 wildfire season heats up, federal and state fire officials – and local rural fire departments – are exploring ways to prepare for the inevitable battles to come as they also face budget challenges.

One new funding source for rural fire departments involves recently announced Community Enhancement Funds (CEF), which will become available later this spring through the Texas Ag Commissioner's Office. This program provides a source of funds not available through other State of Texas Community Development Block Grant Programs. These 100% reimbursement grant monies are being set-aside primarily for rural communities, and the amount of each grant is between \$100,000 and \$350,000. The grants are ideally suited for rural Texas fire departments that desire to ramp up their wildfire protection capabilities.

To be eligible for CEF monies, the project must be a community facility project, renewable energy project, or a combination of the two that can demonstrate a benefit to all citizens within the jurisdiction. The community applicant must meet the Low and Moderate Income (LMI) national objective for its entire jurisdiction (at least 51 percent LMI). These grants provide an avenue for rural fire departments to obtain enhanced wildfire protection capabilities.

### **HIGHWAY SAFETY**

It has been a long time coming, but firefighters now have the rights to shut down roadways during emergency operations. A new law concerning closure of roadways by firefighters in Texas became effective September 1, 2011.

Working on roadways has become an increasingly dangerous situation for public safety personnel. The increase in population coupled with the development of road-rage has placed numerous public safety personnel at risk. Effective September 1, 2011, firefighters now have the right to shut down lanes of traffic if it becomes a risk to them or their crews while working an accident or a fire along the roadway. The law is under Transportation Code Sec. 546.007 and states:

- (a) This section applies only to a firefighter who is employed by or a member of:
  - (1) a fire department operated by an emergency services district;
  - (2) a volunteer fire department; or
  - (3) a fire department of a generallaw municipality.
- (b) A firefighter, when performing the firefighter's official duties, may close one or more lanes of a road or highway to protect the safety of persons or property.
- (c) The closure shall be limited to the affected lane or lanes and one additional lane unless the safety of emergency personnel operat ing on the road or highway requires more lanes to be closed.
- (d) In making a closure under this section, the firefighter shall deploy one or more authorized emergency vehicles with audible and visual signals that meet the requirements of Sections 547.305 and 547.702.

Remember, this rule applies to general-law cities. These are:

"Cities are classified as either "general law" or "home rule". A city may elect home rule status (i.e., draft an independent city charter) once it exceeds 5,000 population and the voters agree to home rule. Otherwise, it is classified as general law and has very limited powers."

Now that your personnel have the rights to shut down roadways, remember that this rule is only one portion of your tool kit.

We all have the responsibility to make ensure that personnel conducting roadway operations wear the appropriate protective clothing. Bunkers are great for firefighting, and are legal to wear for these operations along the roadway, but reflective materials on the coat and pants must be seen visible. Clean your gear regularly.

If bunkers are not required, vests must be worn. It is the law. According to Federal regulation 23 CFR 634 that became effective November 2008 personnel should be wearing a Type II or III reflective vest meeting ANSI-107-2004 high visibility garment standard. Also, not only should your personnel be wearing the appropriate reflective materials but your apparatus should be reflective as well, front bumper and back chevrons and side stripping. All should be a priority, as identified in NFPA 1901.

Other important factors to consider early notification and temporary traffic control zones. Early notification is one key to success when working around or in the roadway. Warnings or notifications should be placed in all directions of the roadway where roads intersect around the incident. Topography is a great concern when working at a scene. Stop and look around upon arrival to a scene, if you can't see upstream or downstream traffic, the drivers can't see you either. Something to keep on the forefront; drivers can't see over hills or around curves and have sight impairment during adverse weather conditions, which puts you and your crews at risk.

Deploy Early traffic warning signs... Florescent pink signs displaying "Emergency Incident Ahead" can have a Classification B rating which are for higher speeds and are easily deployed by public safety personnel. I encourage working with law enforcement, if necessary, to accomplish these tasks. An example; if your fire units arrive first, radio your local law enforcement agency where to place the signs. If your law enforcement arrives first, they should radio responding fire units where to place the signs. You can find regulations for sign usage at http://www.txdot. gov/txdot\_library/publications/tmutcd.htm. Yes, this is a recommendation that both agencies purchase signs. Remember, we all have a job to perform, but want to go home after the incident. We are there to accomplish our tasks in a safe manner by reducing the seriousness of the situation, not make it worse.

The foundation of the safety zone lies with the temporary traffic control area around the incident itself. Placement of traffic cones, which most of us do a great job on the upstream side, is known as the transition area. Equally important is the buffer area, situated between the transition area and the incident, activity area, termination area, and downstream side of the incident and/or scene. Placement of traffic cones tells other drivers how to proceed around your scene and when to re-enter the normal lane of traffic. Additionally, public safety personnel should consider the cones as an identifier for a safe work area. If someone steps outside of the cone area they immediately step into a high hazard zone.

# **BEST PRACTICES**Recognition Program

The TFCA encourages fire departments to also pursue accreditation through the Center of Public Safety Excellence. The TFCA Best Practices program will help facilitate progress toward national accreditation for those seeking this designation.

The TFCA worked closely with progressive fire officers

throughout Texas to create a program that defines a pathway to organizational excellence that ultimately enhances firefighter safety, long-term planning, standard operating guidelines, deployment analysis, risk management and other administrative functions.

While most communities believe their local fire department is excellent, elected officials, city managers, fire chiefs and citizens have the opportunity to verify this belief by their fire department attaining this best practices designation. It is always preferred to have an independent third party determine if an organization functions at a defined level of excellence.

The TFCA Best Practices program provides a pathway for a fire department to push its level of service to a level of excellence that is validated by independent experts. This designation will demonstrate to customers of these organizations that their fire department is among the very best in the Texas fire service.

### TESTED AT THE POSSUM KINGDOM (PK) COMPLEX FIRES

The following are observations from the chief of fire operations at Santo Volunteer Fire and EMS on the performance of TetraKO at the PK Complex fires:

We cover the southeast corner of Palo Pinto County, and Possum Kingdom (PK) is up in the northwest corner of the county. Our department was part of the response to the infamous PK Complex fires, made up of the combined Hohertz, Jackson Ranch, PK East, and PK West fires.

The morning of April 18th, when we had the big blow up, the TetraKO team had set up shop outside the incident command post. I had taken over command of the Possum Kingdom East portion of the fire the night before from Chief Ranft of the PK Fire Department. When Chief Ranft came back on duty at 8 a.m., he asked me to stay and work operations. When I was taking a break, I saw the TetraKO team mixing its product and getting set up, so I spoke with them.

They were batch mixing and loading TetraKO into vehicles for anyone in the command area that wanted it refilled into their tanks. What a lot of these firefighters started to use TetraKO for was structural protection and pretreatment. That's what one of our engines ending up doing. I told our guys to go over and have our truck filled with TetraKO and to use it for structural protection, mop up and pretreatment.

We saved quite a number of structures, and TetraKO did a great job. The thing I found as the biggest benefit of TetraKO is that it holds the moisture longer and holds up better than Class A foam. TetraKO is thicker in the first place and holds on to the surface better than Class A. I watched them use it and I got feedback from the guys on the engine. They all spoke very highly about the TetraKO!

When you start talking about pretreatment and structure protection around buildings, and for other applications such as well sites, fence lines, or anything like that — I'd say it would work real good. After the PK fire, I didn't hear anything negative from homeowners on washing TetraKO off their homes or vegetation.

TetraKO needs to be shown to some of the fire departments in our county. Many of us seek out mutual aid, we're progressive, and we look for anything that can give us an advantage!

### MDA / TEEX

As we enter the 2013 "Fill the Boot" season, on behalf of the thousands of Texas families served by MDA I would like to thank all of the State Firemen's and Fire Marshals' Association of Texas departments who collected for MDA. Your support has helped the association continue to be able to provide the finest in patient care and services for individuals affected by neuromuscular disease. The economy continues to take a toll

on all non-profits and MDA has been no exception. However, all services provided including twenty-two local clinics, three of which are MDA ALS Research Centers; twenty-one MDA Support Groups and assistance with durable medical equipment continue to be funded. MDA also provides five Summer Camps where Texas kids between 6 and 17 like Dylan Hall have the week of their lives. Finally, MDA is underwriting millions of dollars in research in our state to find the causes and cures for the 43 diseases we cover. This would not be possible without the generosity of SFFMA Departments and the generous citizens who have filled your boots! I know that many of your departments are in rural communities and yet you do a fantastic job on "Fill the Boot". You might not think that what you raise as a small department is important, but it is! Here is an idea of what your department has helped MDA provide based on what you have raised:

- For every \$800 your department raised you sent another kid to MDA Summer Camp. If you raised \$8,000 you sent a whole cabin!
- For every \$70 your department raised you funded one minute of research. In 2012 the average for an SFFMA Department was \$3,500 or 50 minutes of research!
- For every \$500 your department raised you funded the annual repair of a piece of durable medical equipment. If you raised \$2,500 you funded five repairs!

MDA continues to be very cost effective with 77 percent going to patient care and research, 14 percent going to fundraising costs and only 9 percent to management costs including insurance, office space, travel and salaries. Your dedicated efforts make this all possible! If you collected in 2012 thank you and good luck again this year. If you did not support MDA in 2012 I encourage you to do so in 2013. We would love to work with you!

I look forward to seeing each of you in The Woodlands at this year's SFFMA Convention!
