

## 2018 Emergency Responder Health & Wellness Grant

**VFIS of Texas** and **Texas Mutual Insurance Company** are pleased to sponsor a need-based Health & Wellness Grant program for fire departments and non-profit EMS organizations in Texas. Grants up to \$5,000 will be awarded based on financial need and are intended to encourage participation in a health & wellness program to prevent emergency responder deaths and injuries. Departments will need to apply for the grant, expend the funds and then send in copies of receipts in order to receive the grant funds.

### Who is eligible?

All-volunteer or mostly-volunteer fire departments and non-profit EMS organizations that serve a population of 100,000 or less and are legally organized in Texas.

### What is eligible?

Cost for member physicals, exercise equipment or other Health & Wellness related items.

### How it works:

1. Departments should apply for assistance (completed grant application, supporting documentation, & W-9) by December 31, 2017.
2. Applications will be reviewed and notice will be sent to those awarded a grant by January 31, 2018.
3. Departments will be responsible for sending in paid receipts by May 1, 2018 in order to receive reimbursement.
