GOVERNMENTAL AFFAIRS COMMITTEE PURPOSE

- **Develop and maintain** strong working relationships with government entities on behalf of the business community.
- Ensure that local, state and federal elected officials are aware of the concerns of the business community.
- Encourage and insist the views of the business community are carefully considered when weighing legislation and decisions that could impact business growth, job creation, taxes, commerce and regulatory statutes.
- Lead, collaborate or support items and projects which meet our mission.

- Facilitate open dialogue sessions with elected officials and business leaders.
- Inform the business community of upcoming actions and opportunities to effectively weigh in on pro-business policy.
- Engage business owners on policy that impacts their business.
- Offer a collective voice for business including the demands on business and business perspective.
- **Provide information** to support an informed voter base.
- Work toward the common goal of a stronger, more prosperous business community.

CHAMBER BUSINESS PRIORITIES

INSURANCE PREMIUMS TO SMALL BUSINESS - CHAMBER ASSOCIATION HEALTH CARE PLANS

The Chamber prioritizes the need to address the high premiums and deductibles which continue to spiral, crippling small businesses on medical insurance, general liability, workers compensation and flood insurance. The burdens and costs to small business are astounding and the Chamber strongly advocates for solutions, including underlying issues, to this immense problem. The Chamber awaits court challenges to the President's Executive Order in regards allowing businesses in a chamber to band together to allow for more affordable insurance as part of association health plans. We will continue to seek solutions to the substantial costs to independent business owners.

SIMPLIFIED SALES TAX COLLECTION

With the business community bearing the responsibility of sales tax collections compliance and expense, the Chamber supports a simplified sales tax collection and remittance process. Businesses that collect sales tax in multiple parishes and taxing districts have a cumbersome and costly process to follow. Businesses are held accountable for confusion in taxing districts due to the complex address procedures and accessibility.

MINIMUM WAGE

Business owners advise that minimum wage should continue to be determined by market forces. Businesses currently pay more than minimum wage for qualified, skilled workers. Wages should be tied to experience, skill and market variables.

JOBS AND CAREER DEVELOPMENT

Concerns with our employee base are ongoing and continue to get worse. The Chamber advocates for funds for employee training to ensure that not only are larger employers considered, but the employee shortfall and training expense of small businesses are not left off the agenda. Partnerships with the local Chamber community are a solid opportunity to address the problem at a grassroots level and lead to satisfactory results for all employer sizes.

CHAMBER BUSINESS PRIORITIES

TAXES & REGULATORY ISSUES

The burden of taxes and regulatory compliance on businesses are diverting resources. Business resources in this regard have been stretched to the point of breaking. The business community seeks a diplomatic approach and solution to this problem. Concerns with our employee base are ongoing and continue to get worse.

STATEWIDE RIDESHARE LEGISLATION

Because ride share must fill the the gap of transportation needs in Livingston Parish, the Chamber is a signatory of and supports supports comprehensive statewide legislation to allow companies like Lyft and Uber to operate across Louisiana with one clear set of rules for ridesharing paving the way for these innovative transportation services throughout the entire state.

NFIP PREMIUMS - NATIONAL FLOOD INSURANCE PROGRAM

Affordable flood insurance premiums are a necessity in Livingston Parish. The financial stability of the program must be addressed to allow homeowners and businesses to purchase flood insurance at reasonable rates. The Chamber is a signatory of the Coalition for Sustainable Flood Insurance headed by GNO, Inc.

TRANSPORTATION | INFRASTRUCTURE | ROADS

The Chamber aligns with the business community and business organizations to address long overdue traffic solutions through dedicated funding. The Chamber aligns with local elected officials and the priorities which include Highway 447, Highway 190 and the continued widening of I-12 to the state line. The Chamber supports the opportunity to provide roads which connect communities to shopping within Livingston Parish strengthening the tax base.

CHAMBER BUSINESS PRIORITIES

CONSTITUTIONAL CONVENTION 2020

The Chamber supports a Constitutional Convention to address the ongoing issues of limited budget control and restraints. A Constitutional Convention is a method to streamline, simplify and re-structure Louisiana's system of government. Louisiana's constitution is too long and confusing, 10 times longer than the U.S. Constitution, Changed 189 times in 44 years and protects special Interests.

BUSINESS & EDUCATION PARTNERSHIPS

Chamber business and education partnerships include opportunities to connect with and mentor students, programming to assist students in considering the employer's perspective, soft skills and career paths. Employable, career-ready students and community college efforts are also Chamber initiatives.

LITTER PRIORITIES | QUALITY OF LIFE

As a priority of the Chamber to take action on the litter and the message it sends, the Chamber supports legislation which protects organizations who organize such efforts. Collaborations on meaningful projects are a priority to address this issue in our parish.

PARISH MASTER PLAN
