Regarding: Worker Training and Documentation -

The goal of this group is to standardize many of our safety requirements to ease confusion and create more consistent industry requirements. We ultimately want to help and coach trade partners to be more productive and safe while on our sites. Providing job specific safety training has been an OSHA requirement for many years and job/task specific safety training is essential in order for safe and productive operations. Our group has seen a need to refocus on this requirement and communicate to our trade partners that we will be collecting/verifying the training for all trade partners and tiered contractor employees. Beginning October 1st, 2019, all General Contractors listed above will require verified trade specific worker safety training (applicable to their scope of work), including the appropriate documentation meeting OSHA standards for all workers on site. OSHA 10 Hour and OSHA 30 Hour is safety awareness training and does not meet OSHA standards for job/task specific safety training. See OSHA Training Requirements Booklet – OSHA 2254 for specific training requirements. Some relevant training includes, but is not limited to the topics listed on Topics Tab of the excel document.

Prior to mobilization on sites, documentation of the satisfactory completion of such training will need to be provided for review to the site General Contractor (referenced above) for all employees (including tiered contractor employees). Failure to comply with this request can result in delayed mobilization. We have included an excel spreadsheet with vendors, associations, and trainers who can assist with any needed training.

In addition, information regarding the OSHA Outreach Programs in the DC Metro area are included (Vendors Tab). This free service includes consultation visits, training, program assistance and much more.
