#### **WORKSHOP OBJECTIVES:**

- Gain knowledge of the AHCA/NCAL Bronze National Quality Award Application Process
- Understand the Technical requirements of the application process and re-certification policy of the Awards Program
- Review and learn the Bronze National Quality Award Criteria
- Develop the framework of a Quality Award Application

#### WHAT YOU NEED TO BRING:

Please note: All these items are necessary for completing your application.

- A copy of your Mission Statement (and your Vision Statement, if you have one)
- A list of your major employee groups, with number of desired employees for each group and any descriptions of minimum education levels for these groups that you have
- Summaries of resident, family, and other satisfaction surveys that you have conducted in the past year
- An organizational chart of your parent company
- A basic geographical description of your local market area
- The names of the data sources that you currently use to access comparative and competitive data
- The steps in your process to fix problems or make improvements
- One thing you have improved or fixed using the steps above.
  Include any numerical measure of the improvement.

SNF/ICF: this should be clinical in nature.

AL: identify a second improvement or fix using the steps you listed, and a numerical measure of the improvement

#### The intent to apply is due November 8, 2018.

AHCA/NCAL encourages facilities to complete an intent to apply.

There is a \$75 fee due with the intent to apply. Applications are due January 31, 2018. The fee if you submit an intent to apply is \$425. If you do not submit an intent to apply, the fee is \$700.
