## 2006 InfoShare Awardees

InfoShare is a program sponsored by SIG III. The program awards one- or two-year ASIST memberships to information professionals in developing countries for whom the cost of membership would be a financial burden.

Sue O'Neill Johnson and Caryn Anderson have served as our InfoShare Co-Coordinator this year. Revenue from the International Reception at the ASIS&T Annual Meeting in Charlotte, North Carolina, USA this past November generated enough funds to make five awards this year. We are pleased to present the 2006 Recipients:

### **Ifeanyichukwu (Ify) Njoku (Nigeria)**

Ifeanyichukwu Njoku is the College Librarian of the Federal College of Fisheries and Marine Technology, Lagos, Nigeria. She holds Master degrees in Library and Information Science and in Public Administration. She is an active member of the IT section of the Nigerian Library Association. She is currently carrying out some studies on the information behaviour of fishermen. She is particularly interested on the influence ICT on information behaviour in developing countries. Ify was the International Paper Contest winner for 2003 and is currently the Co-Chair Elect for SIG-III. Ify was officially nominated by Sue O'Neill Johnson, who notes that Ify has been a tireless advocate for ASIST for the past two years.

### **Dr. P. R. GoswamiDr (India)**

Nominated by Sue O'Neill Johnson, Sue says, "He has been to three ASIST meetings ... and has been extremely valuable in getting participation from Delhi in our International Paper Contest." In addition, Dr. Goswami was the Conference Secretariat and key organizer of the IT in Special Libraries conference held in New Delhi on 9 December 2005 (sponsored by SLA - Asian chapter).

### **J.K. Vijayakumar (Antigua, Indian national)**

J. K. Vijayakumar (Vijay) is the Assistant Director of Library at American University of Antigua, College of Medicine in West Indies. He was a Scientist at Government of India's National Library Network, called INFLIBNET, for seven years and contributed towards its various innovative programs aimed at modernizing Indian academic libraries. He secured Masters in Library and Information Science with First Rank from Annamalai University during 1996 and finished Ph.D. in Library Science from Bhundelkhand University during 2002-2005. He was named as "IFLA/OCLC Fellow" in 2002, and was an associate of the Mortenson Centre for International Library Programs at University of Illinois, Urbana-Champaign, USA.

He has received multiple membership awards and travel grants from ASIST, IFLA and the Special Libraries Association in recent years and is a standing committee member in IFLA-UN Section. He co-edited International CALIBER-2004 proceedings and widely published 30 technical papers and reports at the international and national level. He has organized and actively participated in several International and Indian conferences and programs and is an active volunteer for the International Calendar of Information Science Conferences, contributing events regularly. He is also serving on the judging committee for ASIST SIG-III International Paper contest for 2006.

### **Ms. Lkhagvasuren Ariunaa (Mongolia)**

Nominated by Kate Johnson, Lkhagvasuren Ariunaa is the chief executive of InTec Co Ltd, an IT consulting company based in Ulaanbaatar, Mongolia. She is also the team leader of the ICT for Innovating Rural Education of Mongolia project supported by ADB,

JFICT and MOECS. Prior to starting her own company, she was the Director of Information and Civil Society Programmes in 2001 - 2004 at the Mongolian Foundation for Open Society funded by the Soros Foundation. She was the network administrator of UNDP's Mongolia office and afterwards project coordinator of the UNDP and Government of Mongolia project in 1997 - 1999. Lkhagvasuren has a Master of Business Systems from Monash University, Australia, and an MBA from the International Management Centre, Hungary, and Case Western Reserve University, USA.

### **SLA – Asian Chapter Conference**

SLA – Asian Chapter organized a seminar on 'IT Application in Special Libraries' at Indira Gandhi National Centre for Arts (IGNCA), New Delhi on December 9, 2005. As many as 150 library professionals from New Delhi and other places attended the seminar. The message sent by Ms. Jane Macastra, President SLA – Asian Chapter was read out by Ms. Pradnya Yogesh, Librarian, Kanbay Software, Pune. In her message, Ms. Macastra said that the objective of the SLA is to bring the members of the SLA and non-members together on a platform for professional development. Mr. Debal C. Kar, Secretary, Asian Chapter was the Organising Secretary for this seminar. There were seven invited speakers which included (i) Dr. H.K. Kaul on 'Information Professionals in the knowledge Sector: Their Changing Role in Special Libraries'; (ii) Dr. Ms. Usha Mujoo Munshi on 'E-Scholarship: Initiatives at the Indian National Science Academy for Dissemination of Information in Special Libraries'; (iii) Dr. Mrs. S.P. Singh on 'Role of Special Libraries in India and Current Trends' (iv) Dr. Jagdish Arora on 'Open Access and Scholarly Publishing'; and (v) Dr. Ramesh C. Gaur on 'Digital Library Initiatives at the IGNCA'; (vi) Dr. V.N. Shukla on 'Digital Library Initiatives in India'; and (viii) Professor Mrs. Uma Kanjilal on 'E-Learning Development in India'. In the discussion part of the seminar, the participants emphasized the need for a proper policy for digitization programme including development of uniform standards for metadata and use of an open source software like D-Space.

### **LIS education in developing countries**

#### **CALL FOR PAPERS**

The International Information and Library Review is soliciting papers for a special issue addressing the following broad theme:

*LIS Education in developing countries and emerging democracies.*

Libraries and other information services can be significant tools in the economic and social development of developing countries and emerging democracies. Often, however, library and information science education in these countries lacks the expertise and experience to produce librarians who can shape their libraries and information services to function effectively in the global information society. This special issue of The International Information and Library Review will focus on the state of LIS education in developing countries and emerging democracies.

Related themes could include but are not limited to:

- · Case studies of LIS curriculum development in developing countries
- · The social and cultural context of LIS curricula in specific countries
- · Challenges in translating knowledge gained from a Western-based LIS education into a developing world context
- · Use of information and communication technologies to provide access to LIS education to students in developing countries
- · Evaluation of Western-based LIS programs delivered either in face to face or online formats to students from developing countries.
- · Challenges faced by students from developing countries who are enrolled in LIS programs in the West
- · Personal reflections on LIS education in developing countries and emerging democracies

Papers are solicited from LIS practitioners and educators in both the developed and developing world that address the state of LIS education in developing countries in either practical or theoretical terms.

The theme of this year's contest was "Information Realities: Shaping the digital future for all?" The six winning papers were selected from 31 submissions by 42 authors from 12 developing countries.

Principal authors of the winning papers will be awarded a two-year individual membership to ASIST. In addition, the first place winner, Aditya Nugraha will be awarded a minimum of \$1,000 to attend the November 3-8, 2006 ASIST Annual Meeting, in Austin, Texas. The second authors of the second and third ranked papers receive a copy of Berkshire Encyclopedia of Human-Computer Interaction ([www.berkshirehci.com](http://www.berkshirehci.com)) generously donated by Berkshire Publishing Group.

These winning papers and other submitted papers for the competition will be considered for publication by Elsevier's International Information and Library Review, which is edited by Toni Carbo.

Thanks to the generous donations from Eugene Garfield Foundation, Elsevier, the Chicago Chapter and European Chapter of ASIST, University of Western Ontario, Drexel University, Kent State University, LACASIS, International Information Association, and many other organizations and individuals, we have raised \$6550 to support the International Paper Contest. We expect many more donations to be coming in due course.

As Director of the National Social Science Documentation Centre (NASSDOC), Indian Council of Social Science Research (ICSSR), Dr. Goswami's responsibility is to plan and promote library and information services for the institutes of social science that come under the ICSSR fraternity. Presently there are 27 institutes spread all over India that are getting financial support from the ICSSR. Now they are planning to have a Social Science Libraries Network (SSLN) under the aegis of the NASSDOC. The primary objective is to have resource sharing among these libraries particularly for grey literature published in India and also to start consortia based subscription to e journals for these institutes. They are collaborating with the Inlibnet (Information and library network of the University Grants Commission of India). NASSDOC has recently compiled a significant retrospective bibliographic tool. It is known as INSPELi e Indian Social Science periodical literature covering the period 1800 to 1970. NASSDOC has digitised a part of its PhD theses collection in collaboration with Vidyandhi Digital Library Project of Mysore University funded by the Ford Foundation.

## Information Science in Brazil

The history of ideas, as produced by scientists and the institutions that employ them, makes visible the intellectual production in a particular field of knowledge. In the field of Information Science, Brazil holds an annual meeting that examines the history and developments in the field. One forum, in particular, makes this discussion possible: the ENANCIB (National Meeting of Research in Information Science). Through debates, exchange of ideas and of experiences, ENANCIB shapes and strengthens the community, promotes the formation of identity of this scientific field, its visibility, the delimitation of its borders and its relationship with other fields of knowledge. Additionally, ENANCIB allows the establishment of new scientific partnerships and consolidation of existing work groups.

This event has been held since 1994 as a means toward the consolidation and structuration of the Brazilian Information Science field, thus contributing to the development of the country's postgraduate courses.

ENANCIB is held annually at one of the 9 Brazilian postgraduate schools (located at universities in Rio de Janeiro, São Paulo, Brasília, Belo Horizonte, Campinas, Marília, Florianópolis, Salvador and João Pessoa). Faculty members and students (both at the masters and Ph.D. levels) in Information Science and related areas participate in the meeting. The work presented at the ENANCIB meetings reflects the latest research and developments in Brazilian Information Science, as carried out in the various postgraduate programs and institutions. The 6th ENANCIB took place in Florianópolis, in November 2005, and was organized by PGCIN – Postgraduate Program in Information Science, at the Federal University of Santa Catarina. The organizers of the meeting were: Miriam Vieira da Cunha, General Chair, Lígia Café, president of the Scientific Committee, Edna Lúcia da Silva (in charge of students awards), Francisco das Chagas de Souza (in charge of the General Rapport), Estera Muszkat Menezes (in charge of social events), all of them Professors of the Department of Information Science of the Federal University of Santa Catarina. The Scientific Committee was composed by: Lígia Café (president), Nélide González de Gomez, professor, Brazilian Institute of Scientific and Technological Information, José Augusto Chaves Guimarães, professor, São Paulo State University, Suzana Mueller, professor, University of Brasília, Marta Aun, professor, Federal University of Minas Gerais, Katia Carvalho, professor, Federal University of Bahia, Francisco das Chagas de Souza, professor,

Federal University of Santa Catarina, Asa Fujino, professor, University of São Paulo. The attendance at the meeting exceeded 200 people.

The theme of the 6th ENANCIB was: “Scientific policy and challenges to knowledge”. This topic intended to draw attention upon the transformations and challenges faced by this scientific field.

- 125 papers were presented at the meeting. These papers were clustered around seven major working groups:
- WG1 - Historical and epistemological information studies (16 papers)
- WG 2 - Knowledge organization and representation of information (26 papers)
- WG 3 - Mediation, circulation and information use (31 papers)
- WG 4 - Management of information units (13 papers)
- WG 5 - Policy, ethics and information economy (14 papers)
- WG 6 - Information and work (10 papers)
- WG 7 - Information for diagnosis, mapping and evaluation (15 papers)

### **WG1 - Historical and epistemological information studies**

The 16 communications presented in this group dealt with:

- the reconstruction of the history of the field; as well as
- a displacement of the analysis of information practices and processes from the traditional spaces to other spaces and practices, such as portals, Intranets and digital libraries.

Example of papers presented in this work group included:

- “An Epistemological proposal for Information Science”
- “Information, memory and history: the creation of an information system at Rio de Janeiro in the 19th century”

### **WG2 - Knowledge organization and representation of information.**

The main trends for this line of research included:

- search for models that can illustrate theories and concepts of the area
- emphasis on the creation of information and its management in digital environments
- shift from the document as end product to the process of document production

- wider integration of ICT within the concepts or the area. consolidation of the ----interdisciplinary relationships of Information Science

This group presented the idea of the creation of a Brazilian chapter of ISKO (International Society for Knowledge Organization) which has been submitted to the Organization.

Examples of papers presented in this work group:

- “Organization and representation of knowledge areas in Science and Technology”
- “A methodology proposal in automatic indexing using nominal sintagms”

### **WG3 - Mediation, circulation and information use.**

This session focused on ICT use with a special emphasis on information use and diffusion in electronic media, social networks and information flows.

### **WG4 – Management of information units.**

The papers presented pointed to the following features:

- maturity of research on knowledge management, competitive intelligence and organizational intelligence;
- concern for conceptual aspects;
- advances in information appropriation as research theme from the standpoint of management;
- suggestion of new information spaces.

Example of communications:

- “Use of information sources for competitive intelligence”
- “Information architecture to personalized digital libraries”

### **WG5 - Policy, ethics and information economy.**

Highlighted trends:

- focus on the role of State;
- emphasis on the scientific and social crisis as witnessed by the absence of public policy;
- modification of occupational structures through the ICT and network paradigms;
- need to develop research which produce criteria and parameters for the evaluation of information programs and policies.

Example of paper presented:

- “The economic logic of scientific edition”

### **WG6 - Information and work(10 communications).**

Evidenced:

- the diversity of information spaces;
- the necessity of building a theoretical structure which accommodates contributions of sociology, anthropology, semiotics and history.

Examples of papers presented:

- “Visibility of librarian professional practice”
- “Work organization in university libraries”

### **WG7 - Information for diagnosis, mapping and evaluation (15 communications).**

Trends:

- Impulse given by technology to quantitative studies of Information Science
- importance of studies of the scientific and technological information flows;
- contribution of social and cultural concerns in Information Science studies.

Example of communication presented:

- “Study of co-author net and of the interdisciplinarity of scientific production based on the analysis of social networks.”
- “Mapping of an article produced at the Federal University of Rio Grande do Sul”

In summary, the trends across the various working groups evidence the development of Brazilian Information Science, the obvious influence of technologies and the growing maturity of research methods, with prominence of qualitative ones. The papers presented were of theoretical and applied nature, showing progress towards interdisciplinarity evidenced in researches with contributions of areas such as Administration, Computer Science, Economy, Law, Literature and Education, among others. Moreover, it is necessary to cite the concern with the historical reconstruction of Brazilian Information Science and diversification of workspaces under study.
